Alternatively, we are happy to collect payments by cheque or cash on arrival if preferred.

Last but not least, All attendees will have to present proof of a negative Rapid Antigen Test (RAT) taken within 24 hours in order to enter any of the Club's outlets or function rooms. Members and their guests are required to show a photo of the RAT result with the name, date and time the test was taken. A negative PCR taken within the preceding 48 hours can be used as an alternative.

These requirements have been mandated from the HKSAR Government and are subject to regular official updates. Non-compliance by participants will be subjected to the Government's fixed penalty and will also have a negative impact on the Club.
